4. Consideration to amend Resolution No. 2011-09 establishing qualifications for Veteran exemptions for parking pass at the AI Helenberg Memorial Boat Launch. Amendment would reduce the percentage requirement for service related disability for those under 65 years of age from the current 60% to 30%; comparable to Cowlitz County.

5. Consideration to establish signage for a four-way stop at the intersection of C Street SE/Roake Avenue SE (Councilmember Queen)

6. Reminder of budget workshop meeting scheduled for November 4, 2013 at 6:30 p.m. Location: Castle Rock Senior Center. Continuation of discussion of preliminary budget for fiscal year ending December 31, 2014.
