## 6. CONSENT AGENDA

- **a.** Approval of Minutes May 10, 2010 Regular Council Meeting May 22, 2010 Special Meeting-Council Retreat
- **b.** Ordinance No. 2010-08, an ordinance vacating property platted as a street within the City of Castle Rock commonly known as Front Avenue NW for the purposes of improving access to the Riverfront Trail, on second reading.
- **c**. Request for setting public hearing to consider a budget amendment for the following funds:
- Ordinance No. 2009-14 established a Short Lived Assets Reserve Fund as required by the recent Rural Development loan agreement. This amendment would require \$3,333 per year to be replaced in the reserve fund from the Regional Water Fund, up to a maximum contribution of \$50,000 to be retained until the loan is paid in full.
- Ordinance No. 2010-06 established the Building Code Account Fund, which separated building code funds from the Building and Planning Department within General Fund. This amendment would remove the current adopted allocations pertaining to building permit processes from the General Fund and allocate the same to the newly approved fund.
