## **CONSENT AGENDA**

## **PUBLIC HEARING**

Mayor Helenberg closed regular session at 7:45 PM to convene a Public Hearing to take testimony on the proposed budget for fiscal year ending December 31, 2021, including a proposed 4% increase in water base, 1% increase in sewer base and 2% in consumption utility rates.

First Public Hearing was held November 9, 2020 at 7:45 PM.

Public Comment: Councilmember Simonsen stated with the current economy, he would like to see the 2% proposed increase on the consumption rate is not added and that the City absorbs the costs. Mayor Helenberg added that no increase this year could potentially mean a higher increase next year. He added that five or six years ago, the engineer that did the water system update recommended a 6 or 7% increase each year just to keep up with the expenses and infrastructure. Additionally, staff did a really good job of trying to keep the increase to the base rates to a bare minimum. Public Works Director Dave Vorse added that the 2% proposed increase to the consumption is \$0.28 per 100 cubic feet (this includes both the water and sewer portion).

Lori Gallow, 224 Kirby Ave, stated that though times are hard, she would rather pay the smaller increase now, rather than a bigger increase later. Mayor Helenberg clarified that on a 500 cubic foot bill, the increase would be \$3.69 with the proposed increases. Ms. Gallow added that this summer the Public Works crew fixed the water main in front of their house and she appreciated how wonderful the crew

was. She added that when the lines need to be repaired or replaced, they need to be done now and not later, adding that you're just going to pay more later.

There being no other public comment offered, Mayor Helenberg closed the Public Hearing at 8:00 PM and reconvened regular session.

  - Councilmember Kessler made a motion, seconded by Queen to approve Ordinance 2020-06, on second reading. Motion carried by roll call vote. Councilmembers Lee, Kessler, Queen, Simonsen, and Rose voted 'Aye'.
- 3. Ordinance No. 2020-07, an ordinance amending, City of Castle Rock Municipal Code Chapter 13.16 Retail Water Sales, on second reading.
  - Councilmember Queen made a motion, seconded by Kessler to approve Ordinance No. 2020-07, on second reading. Motion carried by roll call vote. Councilmembers Lee, Kessler, Queen, Simonsen, and Rose voted 'Aye'.
- 4. Ordinance No. 2020-08, an ordinance adopting the budget of the City of Castle Rock, Washington for the fiscal year ending December 31, 2021, on second reading.
  - Councilmember Queen made a motion, seconded by Kessler to approve Ordinance No. 2020-08, on second reading. Motion carried by roll call vote. Councilmembers Lee, Kessler, Queen, Simonsen, and Rose voted 'Aye'.
- 5. Ordinance No. TBD-2020-01, an ordinance adopting the budget of the Castle Rock City Transportation Benefit District, Castle Rock, Washington for the fiscal year ending December 31, 2021, on second reading.
