ORDINANCE NO. 2018-04

AN ORDINANCE AMENDING, IN PART, CASTLE ROCK MUNICIPAL CODE, TITLE 9 PUBLIC PEACE, MORALS AND WELFARE TO ADD A NEW SECTION IDENTIFYING ALLOWABLE PERIODS FOR DISCHARGE OF FIREWORKS WITHIN THE CITY LIMITS OF THE CITY OF CASTLE ROCK, WASHINGTON.

WHEREAS, at the July 10, 2017 regular meeting of the Castle Rock City Council, Mayor Helenberg appointed a committee to address concerns over the discharge of fireworks within the city limits; and

WHEREAS, the Fireworks Committee completed their research and formulated a proposed ordinance regulating the discharge of fireworks on July 4<sup>th</sup>.

WHEREAS, this ordinance, was introduced at a regular meeting of the Castle Rock City Council held on June 25 and at a Special Meeting held on July 2, 2018.

THEREFORE, the city council of the city of Castle Rock DO ORDAIN AS FOLLOWS:

Section 1. A new Chapter shall be added to Title 9 PUBLIC PEACE, MORALS AND WELFARE of the Castle Rock Municipal Code to read as follows:

Chapter:

9.21 DISCHARGE OF CONSUMER FIREWORKS - RESTRICTIONS

Section

9.21.010 Sales and Purchases of Consumer Fireworks

A. It is legal to sell and purchase consumer fireworks, as that term is defined by state law pursuant to RCW 70.77.136 or as subsequently amended, within the City of Castle Rock pursuant to RCW 70.77 and CRMC 5.32.

9.21.020 Consumer Fireworks – Permitted Use and Discharge

A. Consumer fireworks may only be used or discharged on July 4<sup>th</sup>, between the hours of 9:00 a.m. and midnight (12:00 a.m.).

B. Consumer fireworks may only be used or discharged on New Year's Eve between the hours of 6:00 p.m. on December 31st and 1:00 a.m. on January 1st.

Section 2. This amendment shall take effect one year after adoption in accordance with RCW 70.77.250(4) and shall be enforceable in accordance with RCW 70.77.250(5)..
